

# Privacy Policy

This is the official Privacy Policy of Pitak Marketing, Trading as Pitak Solutions, herein referred to as Pitak Marketing. This Privacy Policy is intended to inform you of our policies and practices in regards to the collection, use, and disclosure of any information which you submit to us.

By accessing or otherwise using this site, you agree to the terms and conditions set out in this Policy.

## Collection of Personal Information

- We will never collect any information about you which you do not personally submit to us voluntarily. *(eg, we do not track any other websites you have visited).*
- We do not track or retain any information about you whilst using our website.
- You may use this website without entering any details.
- You may download any document or presentation which appears on this website for your own personal use without entering any details. *(Copyright still exists on all our material).*
- There is never any obligation to enter any information on this website unless you wish to receive our offers.
- We do not, and will never, ask for any information which does not directly relate to enabling you to receive the offers mentioned on our website
- If you do submit any information on this site, you do so voluntarily.
- If you do choose to submit information so as to receive the offers mentioned on our website then there are certain fields which are mandatory for you to fill in to enable us to properly fulfill your request.

## What Personal Information Do We Collect?

We only collect information about you which you voluntarily submit to us. This information is limited to:

- Name
- Contact Phone Number
- Post Code
- Email Address
- Where You Heard About Us

*Which may also contain information you submit to us about:*

- Your Suburb
- Additional Information About Where You Heard About Us.

## How We Use And / Or Distribute Information You Give Us

Pitak Marketing exists to bring together people who are looking for an opportunity and those leaders who are able to help them get started in a home based business. As such, the sole reason for a person submitting their information to Pitak Marketing is for us to connect them with a leader in one of these companies.

By submitting your details to Pitak Marketing, you are requesting us to pass on your details to a third party person who has paid a fee to Pitak Marketing to receive such information. By submitting your details to Pitak Marketing, you are requesting and consenting to this happening.

Pitak Marketing receives a fee from third party people to receive the information which you provide. Beyond this, Pitak Marketing will never re-sell your information to any other persons, companies or organisations.

So as to protect your privacy and ensure that people who respond to our website are never bombarded with approaches, information which you provide us, as outlined above, is used only once and is only ever given to 1 third party person.

Upon being allocated to 1 third party person, your information is set aside and will never again be used. Pitak Marketing will retain your information in a separate data base for verification purposes. After 6 months, your information will be deleted from our data base.

## The Responsibilities Of Third Party Persons Who Receive Your Information

Pitak Marketing receives a fee from third party people to receive the information which you provide. The fees paid will vary depending on a number of factors. Information regarding fees paid by third party people to Pitak Marketing are privileged and will not be disclosed to any other party.

Third party people wishing to enter into such agreements must be able to demonstrate a sufficient expertise, experience and leadership in their respective Business Opportunities. To this extent, it must be possible for a prospective third party person to assist a new person (*one who has submitted their details to Pitak Marketing*) to, as a minimum, achieve the examples set out on the Pitak Marketing website and other documents available for download on the website.

Before they can receive any information which people have provided on our website, third party people must sign confidentiality agreements which amongst other things, set out the following conditions:

- Third party people agree to keep all information they receive from Pitak Marketing confidential.
- Third party people agree that they will never sell, or in any other way, allow information provided to them by Pitak Marketing to come into the possession of any other person, company or organisation.
- Third party people must not use any information given to them by Pitak Marketing in any manner other than that by which it was intended to be used.
- Third party people will delete any personal information once it is no longer relevant.
- If a person who has been contacted by a third party person after submitting their details on the website informs that person they are not interested in the opportunity being presented, that third party person must immediately delete all such information.
- Third party people must immediately delete any personal information upon a request by that person to do so.
